

**COVID-19 WAIVER**  
**for GCA Conference May 4-8, 2022**

***(This is the text of the waiver you will be asked to sign upon Check In)***

I acknowledge the contagious nature of the Coronavirus/COVID-19 and that the CDC and many other public health authorities still recommend practicing social distancing.

I further acknowledge that the Gay Coaches Alliance (GCA), in accord with Easton Mountain has put in place preventative measures to reduce the spread of the Coronavirus/COVID-19.

I further acknowledge that the Gay Coaches Alliance cannot guarantee that I will not become infected with the Coronavirus/Covid-19. I understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, the Gay Coaches Alliance, the Easton Mountain staff, and other guests.

I voluntarily am attending the GCA conference at Easton Mountain from May 4-8, 2022 and acknowledge that I am increasing my risk to exposure to the Coronavirus/COVID-19. I acknowledge that I must comply with all set procedures to reduce the spread while attending the retreat.

I attest that:

- I am not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- I do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- I have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non-contagious by state or local public health authorities.

- I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.
- I am following any travel advisories issued by New York State Governor Kathy Hochul
- I have not been contacted by a health official telling me I may have been exposed to the virus and need to be tested.
- If anything changes concerning the above statements, I will notify the Gay Coaches Alliance conference organizers as soon as possible.

I hereby release and agree to hold the Gay Coaches Alliance (GCA) harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act by GCA, or that may otherwise arise in any way in connection with any services received from GCA.

I understand that this release discharges GCA from any liability or claim that I, my heirs, or any personal representatives may have against the GCA and those individual members of the organization functioning on behalf of GCA as staff, governing board, or conference organizers or volunteers with respect to any bodily injury, illness, death, medical treatment, financial losses, expenses incurred or property damage that may arise from, or in connection to, any services received from GCA regarding this conference. This liability waiver and release extends to GCA together with all members, partners, and employees.
